

## **Next Steps – How to Earn the TIIA & CISR Designations**

1. **Pass your remaining TIIA exams**

Complete on-demand TIIA classes and exams. You must contact IIAT at [education1@iiat.org](mailto:education1@iiat.org) by April 1, 2023 to learn about class options and establish a completion plan.

2. **After you complete your remaining class(es) and exams, please notify IIAT at [education1@iiat.org](mailto:education1@iiat.org) and we'll send your diploma.**

3. **Complete a CISR Course**

After passing your remaining TIIA exams, you are eligible to receive the CISR designation upon completion of a CISR course per the guidelines below.

4. **Receive Confirmation from The National Alliance.**

The National Alliance will send confirmation of your attainment of the CISR designation. Please allow up to two weeks for processing.

5. **Maintain the CISR Designation**

To maintain the CISR designation, you must complete an annual update requirement.
